**NARRATIVE**

On 07/17/2020 at about 1204 hours, I was dispatched to a threat located at 7914 242<sup>nd</sup> St SW in the City of Edmonds, Snohomish County.

I contacted Adrienne Fraley-Monillas and she told me the following:

At about 0540 hours, Fraley-Monillas received a disturbing voicemail on her city cellular phone.

I reviewed the message with Fraley-Monillas. I heard what sounded to be an older male voice. During the message, a caller made several insults, racial slurs, and expressed anger about liberals, Black Lives Matter, and de-funding Police.

Fraley-Monillas sent me an electronic mail containing the audio recording of the message. She did not know who the identity of the male voice and the number was listed as "unknown" on her phone.

I provided Fraley-Monillas my contact information and the case number.

At the Police station, I submitted an audio recording of the voicemail with the report.

I contacted Fraley-Monillas and advised her I would send her a statement to complete via electronic mail (this was later sent). I will document receipt of the completed statement in a supplemental report when it is received.
